## **Booking Terms and Conditions**

The property known as La Petite Espérance is offered for holiday rental subject to confirmation by Janet & Gavin Eastman (the owners) to you the client.

To reserve the property, you should complete and sign the booking form and return it together with the non refundable deposit of 25% of the total rent due.

Following receipt of the booking form, and bank clearance of the deposit, you will receive confirmation of the booking.

If payment of the balance is not received by the due date, (eight weeks before the date the rental period commences), we, the owners, reserve the right to give notice in writing that the reservation is cancelled. The client will remain liable to pay the balance of the rent, unless we are able to re-let the property. **For this reason, we strongly advise you to arrange comprehensive travel insurance, including cancellation cover.**

In case of damage to the property or its contents, an appropriate amount will be deducted from the damages deposit, the balance will be returned within two weeks after the end of the rental period.

Please note that our insurance does not cover loss or theft of the client's personal belongings.
